2024-25 YOUTH PERFORMANCE PROGRAM

Our season will run from October 8, 2024 through May 11, 2025. Total, annual tuition is inclusive of all classes and in-studio rehearsals, registration fees, administrative fees, studio membership and new season welcome bundle. Our program guarantees 24-weeks of instruction, whether online, in-studio or a combination thereof (hybrid model).

Priority rates & installment plan apply to the accounts of students registered for classes during the preseason promotional period, with first installments drafted by May 31, 2024.

Studio merchandise and class uniforms are <u>not</u> included in tuition. Please see separate <u>Dress Code Policies</u> for class attire information. Performance costumes, event participation, professional video and class photos all sold separately.

PAYMENT POLICIES

- · Cash, checks and all major credit/debit cards accepted.
- All families must place a valid credit card on file to register for any class. Once registration is confirmed with first and last
 installments paid upfront, remaining installments will be auto-drafted between the 1st-3rd of each month thereafter, until the total
 balance for the season is paid in-full (no later than May 3, 2025). Other methods of payment gladly accepted before each installment
 due date— please reach out to info@performingartsworkshop-nj.com before the 1st of the month to make alternate arrangements,
 as needed.
- If you plan to pay with a check before tuition is auto-drafted, please make payable to Performing Arts Workshop and hand it directly to the front desk staff at drop-off; or leave it in the lockbox on the building door; or mail to Performing Arts Workshop, 196 Morgan Street STE 1, Jersey City, NJ 07302 before the 1st of the month. Please Note: there is a non-negotiable \$50 fee added for all returned checks. If you plan to pay with cash before tuition is auto-drafted, please prepare an envelope with exact change and hand it directly to the front door staff at drop-off. Do not mail cash, and do not leave cash in the lockbox on our building door.
- All hand-delivered payments should be sealed in an envelope with your child(ren)'s name(s) clearly labeled on the front; and the total amount enclosed must be hand-written inside of the envelope. Please remember to send a message to info@performingartsworkshop-nj.com with your intent to pay tuition by alternate means <u>before</u> the 1st of the month, in order to halt the pending auto-charge.
- Installments are based on the total, annual cost of the program divided into equal payments for convenience. Installments are <u>not</u> based on the number of classes in a month. First and last installments are due at time of registration to confirm enrollment and are non-refundable. Account balances are drafted in equal monthly payments, from the time of registration through May 3. If account balances are greater than the amount of one installment by May 3, total remaining fees will be drafted on that date. Pay-per-class and drop-in options are not available for this program.
- All paid tuition is non-refundable. This includes any payment-in-full, lump sum or advanced payments accepted for the 2024-25 season.
- Studio merchandise is non-refundable and ineligible for any kind of substitution, exchange, prorate, discount, return or replacement. Gifts do not have cash value and are ineligible for any kind of substitution, exchange, return or replacement. Additional merchandise may be available for purchase if you wish to replace any lost items. Please e-mail info@performingartsworkshop-nj.com for prices and availability.
- Trial classes may be arranged for \$20 per class. Families who elect to enroll on the <u>same calendar week</u> as their trial will receive a \$20 account credit. Please e-mail <u>info@performingartsworkshop-nj.com</u> for more information about trial classes.
- We have eliminated late fees, however we kindly ask all families to understand and acknowledge that accounts must be current in order for students to attend any class in which they are enrolled. Please e-mail info@performingartsworkshop-nj.com if you need assistance with your account at any time— we want every child to participate in every class, and we are here to help!

Tuition, Payment & Withdrawal Policies

- Registration is prorated by trimester, only, for students enrolled after the first lesson of the school year. The full value of any lessons missed within a single trimester will be made-up as determined by the program Director (make-up class, additional rehearsal, etc.).
- Tuition is not prorated or refunded for absences, whether planned or unplanned. Students who miss their own class may arrange to take another class appropriate for their age within 2 weeks of the initial absence; and may reschedule a make-up class, once. Please note that make-up classes are not guaranteed if a student's schedule does not align with the studio's advertised class schedule. This courtesy make-up class policy will be in effect through April 11, 2025; After April 11, make-up classes will not be arranged; and recorded lessons/make-ups are not an option for any part of the 2024-25 season. Please e-mail info@performingartsworkshop-nj.com to make all absence-related arrangements.
- Performance costumes will require a separate fee of \$105 child size/\$115 adult size per class enrollment, and will include all required body wear and accessories for the performance. A 25% costume deposit is due November 15, 2024; and the balance of costume fees is due February 15. Performing Arts Workshop will not be responsible if a student does not receive costumes in time for any scheduled event as a result of late payment, partial payment or non-payment by the student's family; and deposit refunds will not be provided for any garments, nor related events, in such instances. Costume fees do not include dance shoes or performance tights, and families will be solely responsible for ensuring their child(ren)'s regular dance class footwear is a proper fit, and in good condition, for our scheduled events. Please see separate PAW Program Policies for more information regarding costume sizing, ordering and delivery.
- Costume fees are non-refundable. Families who opt-out of, or miss, our performances for any reason will still receive costumes at
 the time of in-class distribution, provided tuition is not past-due and costume balances are paid in-full. If tuition is current but costume
 balances are only partially paid, then families who opt-out of, or miss, our performances will not receive costumes; however any
 partial costume payment will convert to a transferrable credit for future classes— and may be gifted to a sibling or friend of age for
 any Performing Arts Workshop program— expiring 365 days from the performance date.
- Paid costume fees will be applied to any past-due balances for merchandise, services and tuition which remain unpaid by
 the time of in-class costume distribution. Under such circumstances, costumes will be not be distributed until the total past-due
 balance is paid <u>and</u> costume balances are paid in-full. Please e-mail <u>info@performingartsworkshop-nj.com</u> for account assistance,
 as needed.
- \$150 per student Showcase Fee due April 15 includes final technical rehearsal, student showcase participation, professional video & class photos (digital delivery within 45 days from event). Sibling Prorate: \$150 for first student and \$115 per each additional student from the same household.
- Tuition & Showcase Fees do not include admission for any attendees to any performance. Ticket fees are determined no later than 8 weeks in advance of our events. We are planning a live showcase to take place on May 10, 2025 in Jersey City & dress rehearsal/portrait days to take place within 2 weeks prior, dates TDB no later than March 2025. If a live event cannot take place at the time of our tentative performance date, as per government ordinance, Performing Arts Workshop will immediately pivot to Showcase Plan B, in full compliance with all local ordinances, as well as all health & safety precautions outlined by local and federal government agencies; and with all procedures, viewing options and related fees to be determined if/when such circumstances arise.

WITHDRAWAL POLICIES

- Withdrawals must be received in writing via e-mail to info@performingartsworkshop-nj.com, at least 30 days prior to the
 next installment due date (1st of the month) in order to prevent further charges and/or auto-drafts. Tuition charges and auto-drafts
 will continue to process as scheduled until such notice is received, after which time any account adjustments will apply from 30 days
 forward. Students with accounts in good standing may continue to attend all classes remaining in the program within the 30 days
 following their notice of withdrawal.
- As previously stated, all paid tuition is non-refundable. Families withdrawn from classes according to our 2024-25 Withdrawal
 Policies will owe nothing more, provided their accounts are current at the time of notice. If a balance remains for merchandise,
 services rendered and/or tuition due prior to the date of notice, and/or if notice is received less than 30 days from the next installment
 due date, Performing Arts Workshop reserves the right to auto-draft the total past-due balance and/or pending installment using the
 method of payment placed on file with our office. Please reach out to info@performingartsworkshop-nj.com to make alternate
 payment arrangements, if needed.
- Paid costume fees are non-refundable, however families withdrawn from the program may pick-up costumes as soon as
 they are delivered to the studio, provided fees for merchandise, services and/or tuition are not past-due at the time of withdrawal
 and costume balances are paid in-full. Paid costume fees will be applied to any past-due balance for merchandise, services and/or
 tuition remaining at the time of withdrawal; and families withdrawn from the program under such circumstance will not receive
 costumes. If all fees for merchandise, services and tuition are paid as agreed but costume fees are partially paid at the time of

withdrawal, then families withdrawn from the program will not receive costumes; however any partial costume payment will convert to a transferrable credit for future classes— and may be gifted to a sibling or friend of age for any Performing Arts Workshop program—expiring 365 days from formal notice of withdrawal.
